#### OPTION 1

##### FINANCIAL ASSISTANCE

Full or partial assistance may be available based on your financial condition and if it is determined in accordance with our Charity Care Policy.

You may contact one of our financial counselors at 708.229.6152 or 6153 for an appointment. For your convenience, financial counselors are available Monday through Friday from 8 a.m. to 5:30 p.m.

A Financial Assistance application is used to determine eligibility. If approved, this program covers medically necessary services provided by the Hospital.

To be considered for a full or partial discount under our Charity Care Policy, you must provide the information and documentation requested in the Financial Assistance application. If you are over 18 years old, you must complete a Proof of Residency Form along with the Financial Assistance application. You must first apply for other existing financial resources that may be available to pay your health care bills such as Medicare, Medicaid, All Kids, Worker's Compensation and other liability claims.

Please complete the Financial Assistance application and the Proof of Residency Form and return it within 10 days to The Business Office at the address below with all the supporting documentation:
